
AND WHEREAS in order to materialize the idea of the Settler as aforesaid the Settler has made over the sum of Rs. 5,00,000/- (Rupees Five Lakh only) as specified in Schedule 'A' hereunder written to the Trustees by way of initial contribution at the present which receipts the trustees herewith admit and acknowledge as per memo of consideration appearing hereunder written. However, the Settler has further agreed to provide all sorts of help to the trustees for establishing institutes as desired and in running the Trust smoothly depending upon necessity.

AND WHEREAS the Trustees have agreed to become Trustees and to hold and apply the said sum of Rs. 5,00,000/- (Rupees Five Lakh only) and to give contributions, subscriptions and donations for the said fund and for such purposes and subject to the Trustees powers and provisions contained in this Deed.

NOW THIS INDENTURE WITNESSETH that in pursuance of the aforesaid desire and for carrying out such desire into effect the Settler does hereby grant, transfer and assign unto the said Trustees the said property specified in Schedule 'A' hereunder written.

taxation of income as will ensure or make the Trust hereby established and its income as eligible for exemption from taxation under the Income Tax Act, 1961, or any replacement or re-enactment thereof or modification thereof or under any other Government taxation for the time being in force in India.

- c) And further so that the Trust hereby established shall be one to which the provisions of Section 80G of the Income Tax Act, 1961, or any replacement re-enactment or the modification thereof for the time being in force shall apply so that any donation thereto be recognized eligible for exemption or relief from tax in regard to the Donor.

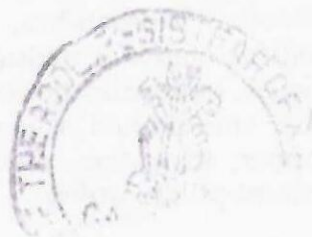

- 5] To provide libraries, reading rooms for the benefit of the studies and other persons for promoting education and social welfare.
- 6] Establishing, maintaining and/or granting aid to Institutions for the life relief of the poor and advancement of the education and also for the purpose of aforesaid to grant periodical and other occasional purposes of aforesaid, also to deserving persons as the Trustees may think fit and proper.



- 16] Setting up or helping by endowments orphanages or poor houses for the benefits of orphans and poor persons and awarding of scholarships and cash payments to poor persons and widows desirous of receiving a primary, secondary and/or higher education and/or research in any branch or branches of science technology, culture, arts etc. in its widest sense.
- 17] To pay tuition fees, examinations fees, boarding and lodging fees to deserving students and to supply books free of cost to such students.
- 18] To make monthly or other periodical or lump-sum grants and contributions for the advancement or education or educational institutions.
- 19] To render financial help to deserving students to enable them to purchase books and other equipments necessary for their education.
- 20] To render financial help to needy and deserving persons to enable them to obtain medical treatment either in India or abroad in cash or in such other forms and no such terms and conditions as Trustees shall deem fit PROVIDED HOWEVER that in case of medical treatment to be obtained abroad, financial help should be rendered in India.

- 24] To establish or to aid school, colleges for adult education and general awareness to the poor, downtrodden, illiterate persons irrespective of caste, creed, sex, religion.
- 25] To give education and/or aid to the existing schools as the Trustees may deem fit and proper.
- 26] To give financial help to needy widows and orphans for the purpose of their maintenance, medical treatment and education specially in arts and crafts so as to enable them to earn their live hood.

- 31] To print, publish, sell, purchase, distribute free of cost or at a nominal price or on concessional rate book magazine, bulletin, leaflets, journals and other periodicals for advancement of education amongst different sects of people or in

- 35] To carry on and help in the matter of research on medicine, disease and other spheres and to do all other acts, deeds and things for causing research in any other field as the Trustees may deem fit and proper.
- 36] To do social welfare and to propagate Indian Culture amongst the general public and to do all acts, deeds and things as may be necessary for social welfare, harmony in community, educational development and other advancement and / or improvement of general public at large and for uplifting of their mental attitude.
- 37] To carry on any business for the benefit and for augmenting the Income of the Trust and to utilize the same for the object of the Trust and to do all acts, deeds and things as may expected to be done by the Management of the business in its normal or usual course.
- 38] Without distinction and irrespective of religion, castes or creed to give relief to poor, relief to the deserving, medical relief advancement and propagation of any object of general public utility, public institutions, maintenance and support of the schools, educational institutions, hospitals, relief of any distress caused by the elements of nature, give educational grants and assistance in advancement of learning in all its branches, establishing research work in connection with medicine, literature, technology, science, industrial problems or for providing funds for institution and/or starting professorships or lectureships or giving scholarships in any branch of medicine, family planning, science, technology or commerce.
- 39] To undertake any programme of rural development including any programme for promoting the social and economic welfare of or the uplift of the public in any rural area and the funds of the association/ institution raised for this purpose would be utilized for the above object. PROVIDED FURTHER THAT every contribution by Trustees to any other trust, society or institution fund scheme or object having as its sole object all or any of the aforesaid public charitable trusts and objects shall be treated and deemed to be a furtherance and achievement of the object for this Trust. PROVIDED FURTHER THAT notwithstanding anything contained hereinabove the Trustees shall have an absolute power by deed inter vivos or such other document as may be necessary to delete any of the objects or provisions of any part of the aforesaid Trust which are found contrary to the objects or outside of the Indian Income Tax Act, 1961, or any re-enactment, replacement or modification thereof and other taxation laws as may be applicable from time to time and enforced in India.

- 41] The trust will never perform any acts which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country.
- 42] The trust will never act as a micro financing and any act under Money Laundering (Act 2012) in nature and shall not obtain any donation or other benefits from abroad without getting the necessary permission of FCRA ACT from the Central Government/competent Government authority.
- 43] All aims/objects/purpose of the trust herein stated above shall come into effect /force after necessary appointment of the competent Government authority in the case where affiliation /permission/ license /sanction is required.

- II] The Trust hereby established shall be designated as SWABHUMI INDIA FOUNDATION and the said name shall never be changed. The Trust office shall be situated at 37, Jessore Road, Police Station - Dum Dum, District - North 24 Parganas, Pin - 700 074, and/or such other place or places as the Trustees may from time to time determine.
- III] The Trustees shall be entitled at such time or times as they think fit and at their unanimous absolute discretion to sell and convert the Trust Funds or any portion thereof.
- IV] All moneys forming part of the Trust Funds and requiring investment shall be invested in the name of the Trust or in the names of all the Trustees, for the time being of these presents or where allowed in name of the Trust in or upon any of the securities authorized by law for investment of Trust Funds or in the purchase of shares. (Preference or Equity) of any company or companies or in or upon the purchase or first legal mortgage of immovable properties. PROVIDED HOWEVER THAT in case of leasehold properties for a TERM, 30 years at least or such term shall be unexpired at the date of such investment or purchases or purchases and with liberty to the Trustees in case of leasehold properties to waive the production of the Lessor's title and also in or upon stocks, funds, shares, debentures, debenture stock, mortgage or securities of any Corporation, companies or public body, Municipal, Commercial or otherwise or in or upon stocks, funds, shares debentures, debenture stock, mortgage or securities of any public body, municipal commercial or otherwise or in or upon current accounts or deposits with any Bank or Banks and Trustees shall be entitled from time to time to vary and transpose the said investments into or for others of the same or a like nature. The Trustees shall also be entitled to keep maintain the account or

accounts of the Trust and the Investments of the full or part of the Trust Funds with any person or persons companies (whether public or private), Firm or firms or any other funds or institutions as they may in their absolute discretion think fit subject nevertheless to the compliance of all legal formalities necessary and under the laws for the time being in force.

- V] The Trustees shall have power in their discretion so far as the income of the Trust Funds or any part thereof shall not be applied in and upon the Trusts under these presents, to invest and accumulate the same in the names of the Trustees at their discretion to vary and transpose any investments for others of any nature hereby authorized. The Trustees shall stand possessed of such accumulation upon the same trusts as are hereby declared of any concerning the Trust Fund PROVIDED ALWAYS that the Trustees shall be at liberty to apply the whole or any part or parts of such accumulations at any time in or towards the trusts herein contained as if the same had been the income arising in the year in which the same shall be so applied.
- VI] The Trustees shall have power in their discretion to accept upon such terms as they may think fit any donations or contributions which any person may be desirous of making to the Trust Funds (whether such donations, contributions be of money shares and securities, debentures, bonds, stocks, and/or other property, movable and/or immovable), PROVIDED ALWAYS THAT the terms upon which such donations or contributions shall be accepted shall not, in any way, be accepted shall not, any way, be inconsistent with or repugnant to the objects of these presents and shall only be for the purpose of the Trusts created under these presents to be utilized only in furtherance of its objects. PROVIDED ALWAYS AND IT IS HEREBY AGREED AND DECLARED that save as otherwise expressly provided by the terms of the donations, or contribution aforesaid the Trustees shall, in their absolute discretion, be entitled to treat such donations or contributions or any part thereof as part of the corpus of the Trust funds or to utilize such donations or contributions or any part thereof for the furtherance and fulfillment and fulfillment of the objects of the Trust.
- VII] The Trustees shall have the power to let, subject or part with possession or to grant leave and license or otherwise the immovable properties belonging to the Trust from month by month and from year to year or for any term of years or in perpetuity and to sell, exchange and purchase immovable properties upon such terms and conditions as they may, in their discretion, deem fit from time to time with mutual consent of all the Trustees.

- VIII] The Trustees shall keep the movable and immovable properties from time to time forming part of the Trust Funds in repairs and duly

- IX] The Trustees shall have the power in their discretion to make any additions, alterations and improvements to the immovable property or properties of the Trust Funds and to develop the same from time to time in such manner as they. In their discretion deem fit and proper from time to time, with mutual consent of all the Trustees.
- X] The Trustees shall at all times be entitled to sell or otherwise dispose of any property belonging to the trust comprised in the Trust Funds which does not consist of money for such consideration and upon such terms as the Trustees, in their discretion, may deem fit and proper, with mutual consent of all the Trustees.
- XI] The Trustees shall if the situation so required be entitled in their discretion to borrow moneys upon such terms, conditions and securities as the Trustees in their discretion deem fit and proper from time to time and to manage the Trust property comprised in these presents as security for repayment of the loans borrowed for the purposes of the trust, with mutual consent of all the Trustees.

BANK ACCOUNT

- XII] The Trustees shall be entitled to open and maintain Bank account in the name of Trust. The Bank account will be operated by Two Trustees, One from each family, that is one from SAHA family and one from DE family. For inclusion of more signatories in Bank account, a separate resolution has to be passed by Board of Trustees, but whatever be the resolution, the signatories from each family will be equal in number.
- XIII] All the Trustees with mutual consent shall have full power to apportion the Trust Funds and to compromise or compound all actions, suits and other proceedings and all differences and demands and refer any such differences or demands to arbitration and to adjust settle and approve all audited accounts relating to the Trust Funds and to execute releases and all documents necessary in the premises and to do all other things relating thereto respectively as fully as if they were absolutely entitled to the Trust Funds and without being answerable for loss occasioned thereby.
- XIV] Instead of themselves spending any sum for any purpose authorized by these presents or by law or by statute the Trustees with mutual consent shall have full power to pay any sum for the purpose of such expenditure to the Treasurer or Secretary or other official or any institution without being bound to look after the application thereof and the receipt of any such Treasurer, Secretary or official shall be a

complete discharge to the Trustees for such payment and for seeing to the application thereof, subject to necessary permission required under any law for the time being in force relating to the purpose of the Trust.

XV] All the Trustees with mutual consent shall be empowered to carry on any trade, industry or exhibition which in the opinion of the Trustees and subject to the provisions of Indian Income Tax Act, 1961, Indian Trust Act, 1882 for the time being in force are permissible and are essential, incidental or conducive to the attainment or for the fulfillment of all or any of the objects of the Trusts.

XVI] The number of Trustees of these presents shall not be less than four and not more than eight in numbers and the Trustees shall be entitled to appoint additional Trustee or Trustees as and when the Trustees unanimously decide the same by appropriate resolution. If resolved, then from the family of each trustee namely Sri Uttam Kumar Saha, Sri Dipak De there can be at best four members from each family. In case of total four members of trustees there will be two members from each family and in case of total six numbers of trustees there will be three members from each family and in case of eight members of trustees there will be four members from each family. If in future, it is required to increase the number of trustees in the board more than eight, then it can be done by a separate resolution where ALL the eight trustees will have to give consent for increasing the number of trustees more than eight, and in all cases the number of Trustees from each family should be equal in number. The said Trustees of these presents shall act as Trustees for life or until they resign or otherwise vacate their respective office or are removed as hereinafter contained. However, each of the individual trustees shall be entitled to nominate trustees in their respective place from amongst individual trustee's family members only or will be appointed by the way of inheritance from the respective family.
